VOLUNTEER RELEASE AND WAIVER OF LIABILITY FORM

releases FoodRenew, a social action project group and its core team members, existing under the laws of the Province of Saskatchewan. The Volunteer desires to provide volunteer services for FoodRenew and engage in activities related to serving as a volunteer. Volunteer understands that the scope of Volunteer's relationship with FoodRenew is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that FoodRenew will not provide any benefits traditionally associated with employment of Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to FoodRenew.

1. <u>Waiver and Release</u>: I, the Volunteer, release and forever discharge and hold harmless FoodRenew and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to FoodRenew. I understand and acknowledge that this Release discharges FoodRenew from any liability or claim that I may have against FoodRenew with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to FoodRenew or occurring while I am providing volunteer services.

- 2. <u>Insurance</u>: Further I understand that FoodRenew does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of FoodRenew.
- 3. <u>Use of Personal Vehicle</u>: If using a personal vehicle you must have a valid driver's license and proof of current insurance. Please note that your personal vehicle insurance must pay if your vehicle is involved in an accident. You may need to check with auto insurance carrier to ensure you are protected in this event.
- 3. <u>Medical Treatment</u>: I hereby Release and forever discharge FoodRenew from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with FoodRenew.
- 4. <u>Assumption of Risk</u>: I understand that the services I provide to FoodRenew may include activities that may be hazardous to me including, but not limited to lifting or loading food, riding a bicycle in an urban environment, or operating an automobile. As a volunteer, I assume risk for injury, illness, death, or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services. Also. I hereby expressly assume risk of injury or harm from these activities and Release FoodRenew from all liability.
- 5. <u>Photographic Release</u>: I grant and convey to FoodRenew all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by FoodRenew in connection with my providing volunteer services to FoodRenew.
- 6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the Province of Saskatchewan and that this Release shall be governed by and interpreted in accordance with the laws of the Province of Saskatchewan. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
